Offense: Murder 1st

On 09/27/08 at 1936 hours the North Little Rock Police Department Patrol Division responded to a black male lying in the street bleeding from the face in the 500 block of Main Street. Upon arrival to the area, officers located a black male lying on the sidewalk in front of an apartment door. He was bleeding and had multiple injuries. The victim was transported to Baptist Memorial Hospital where a short time later he was pronounced dead by hospital personnel. A preliminary examination of the crime scene revealed what appeared to be blood smears on the door leading into 500 Main Street, Apartment # C. Contact was made via telephone with the resident, Donald Grace, who agreed to exit his residence and speak with Detectives. When Grace opened his door, Detectives observed large amounts of what appeared to be blood, one of the victim's shoes and a baseball bat covered in blood in the foyer. Grace exited the building and the apartment was secured until a Search Warrant could be obtained. Once Detectives entered the apartment, a pair of jeans and a shirt with what appeared to be blood on both items, were recovered from the washer. A pair of mens cowboy boots with what appeared to be blood and human tissue on them were located in a closet. After a post Miranda Rights interview, Grace told Detectives he was home alone during the late part of the afternoon and into the night. He also advised he was wearing blue jeans earlier in the day but had removed them and placed them in the washer.
