## Political Advertising

Local retail display rates will apply. All political advertising must be cash with order and a signed notice of disclaimer is required before publication. Each ad must state "paid political advertising."

## Rates are net

Ads publishing in the Sunday zone edition may run in the Thursday zone edition for 35% off. The pickup rate will apply to the Thursday prior to the Sunday ad or after the Sunday ad.

## Guidelines Governing Advertising In The Arkansas Democrat-Gazette

Setting of advertising copy, on order of advertiser which is not used, and revising or changing of original copy shall be paid for by the advertiser at cost of composition and other labor. Such revisions or changes of original copy will be made only when it can be done without delaying publication of the newspaper.

Special position of advertisements shall be paid for by advertiser at the rate of 25 percent additional to regular rates, but in case the special position is not given, the advertiser shall pay for space at regular rates.

Slicks or other reproduction materials of advertisers shall be left with the *Arkansas Democrat-Gazette* without liability on its part.

Depth of any advertisement of more than 19 1/2 inches shall be paid for by advertiser on basis of full length column of 21 1/2 inches in depth. Double truck advertising shall be measured as 13 full columns. Spread must be at least 12 1/2 inches deep and comprise a total of 160 column inches. True double truck not guaranteed.

All copy for advertising is subject to approval of the *Arkansas Democrat-Gazette*, the right being reserved to revise or reject any advertising which is deemed objectionable for any reason.


The advertiser shall defend and indemnify and hold harmless *Arkansas Democrat-Gazette, Inc.* against any claim of liability or loss asserted or established against

it by reason of the publication of any advertisement or any part thereof submitted by or published at direction of the advertiser.

It is further agreed that there are no terms or agreements not set forth herein and that the rates and regulations or conditions on the back hereof are part of this contract as fully as if they appeared on its face.

This contract shall become effective on its acceptance by the publisher, general manager, advertising manager or promotions director of the *Arkansas Democrat-Gazette's* Three Rivers Edition and shall run for a period of 12 months as set out above.
